The listed handler would be Agent Eric Flagg.

The agreement was signed on February 7, 2008

by Agent Flagg, Dustin Stanley and signed off on by a Judge in Woodstock, Va.

Dustin Stanley was arrested January 15, 2008

and signed on to work with Agent Flagg

by providing information on stolen firearms

that would be leading Agent Flagg into

West Virginia.

The agreement stated Dustin Stanley was to

report to Agent Flagg or Lt. John Thomas of

Woodstock, daily.

It stated Dustin Stanley was to only

reside at Gracie Stout's home in Mt. Jackson,

Va or be subject to arrest.

It stated Dustin Stanley was to enroll

in a branch of the military 1 year from

the date of the agreement.

Dustin Stanley is deceased and there is no

ongoing active investigation, therefore I am

requesting the agreement pursuant to

the Freedom of Information Act.
