Delivery of Copies of Computer Search Warrant: On 7/31/08 at approximately 2000 hrs, I gave Ms. Hockman (suspect) a copy of the search warrant that allowed for the seizure of computers from her home. Ms. Hockman was in the Rockingham County Jail at the time, so the decision was made to give it to her directly instead of leaving it only at the home where she may never receive it if she should never make bond.

Ms. Hockman was upset that I did not go through her attorney first before seizing her computers. As I was making my way to the door, Ms. Hockman asked me a detailed question about the status of her cell phone. I displayed visual body motions and facial expressions consistent with not being permitted to answer, concurrently while I began to respond by saying that I could not speak to her about anything of substance without rereading her Miranda Rights and without her attorney. However, Ms. Hockman cut me off as she saw my hesitation in answering her question. She immediately switched gears and asked me a minor question about whether or not I was the same Kevin Shifflett that interviewed Ms. Sherrine Swan on this day. I answered in the affirmative and then continued leading her out.

This conversation was very short and was recorded via a digital recorder.

Delivery of Copies of Search Warrants involving: a) Computers' Electronic Examination and b) MySpace: On 8/21/08 at approximately 1955 hours, I gave Ms. Hockman copies of the search warrants involving: a) computers' electronic examination and b) MySpace. Ms. Hockman was in the Rockingham County Jail at the time.

Ms. Hockman quickly read over the MySpace search warrant. On my way out the door, Ms. Hockman asked me [redacted] was (a phrase that is listed on the search warrant). I answered her and then left.

Sprint Phone Calls: On 8/25/08, Captain Barry Wittig spoke to me about the possibility that Ms. Hockman's voicemails may have automatically expired or been purged from her system unless she or her attorney recently resaved them. Captain Wittig recently found out that Ms. Hockman's cell phone number was registered with Sprint instead of Intelos, as he had previously been informed.
